If the final cost of the order contains an obvious price error, the seller reserves the right to withdraw from the contract or, after individual communication, adjust the final price of the order in the correct form.

The seller has the right to cancel the order or withdraw from the contract in case the sold goods are no longer produced, or if a price error occurs in the order, which greatly affects the real loss. In this case, the seller will contact the buyer and individually resolve the problem. Seller is not responsible for damages caused by not delivering the goods.
